## MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998)

## FISHING RIGHTS ALLOCATION PROCESS 2021/2022 - PROPOSED FEES PAYABLE IN RESPECT OF APPLICATIONS FOR COMMERCIAL FISHING RIGHTS AND GRANT OF RIGHTS

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment hereby, in terms of sections 25(1) and (2) of the Marine Living Resources Act, 1998 (Act No. 18 of 1998), publish for public comment, proposed fees payable in respect of applications for commercial fishing rights and fees for the issuing of commercial fishing rights for a Fishing Rights Allocation Process, as set out in the schedule hereto.

It is proposed that the fees be increased by the Consumer Price Index (CPIX) - currently 5.2%. Any person who wishes to comment on the proposed fees may submit written comments to the Department:
